MINUTES CITY OF DEKALB CITIZEN POLICE REVIEW BOARD October 10, 2024

The Citizen Police Review Board (CPRB) of the City of DeKalb, Illinois, convened on October 10, 2024, at the DeKalb Police Department, 700 W. Lincoln Highway, DeKalb, Illinois.

A. CALL TO ORDER AND ROLL CALL

Chair Maurice called the meeting to order at 6:11 p.m.

Board Secretary Melissa Neblock called the roll, and the following members of the CPRB were present: Maurice McDavid, Kelvy Brown, and Justin Carlson.

B. APPROVAL OF THE AGENDA
