MINUTES CITY OF DEKALB CITIZEN POLICE REVIEW BOARD March 13, 2025

The Citizen Police Review Board (CPRB) of the City of DeKalb, Illinois, convened on March 13, 2025, at the DeKalb Police Department, 700 W. Lincoln Highway, DeKalb, Illinois.

A. CALL TO ORDER AND ROLL CALL

Chair Maurice called the meeting to order at 6:09 p.m.

Board Secretary Melissa Neblock called the roll, and the following members of the CPRB were present: Maurice McDavid, Kelvy Brown, and Justin Carlson.

B. APPROVAL OF THE AGENDA

MOTION: Mr. Brown moved to approve the agenda; seconded by Mr. Carlson.

VOTE: Motion carried by a 3-0 voice vote of the CPRB members present.

C. APPROVAL OF THE MINUTES

MOTION: Mr. Carlson moved to approve the minutes; seconded by Mr. Brown.

E. CHAIRMAN UPDATE

Mr. McDavid apologized for not getting the links out for NACOLE website, but he would get that to Ms. Neblock after the meeting.
