### **OBJECTOR'S PETITION**

NOW COMES ALBERT WILLIAM VANSTONE VODDEN, JUNIOR (the "Objector"), who represents that: Objector resides at 220 Delcy Drive, DeKalb, Illinois 60115; Objector is a duly qualified, registered, and legal voter at said address; Objector's interest in filing the following objections is that of a citizen who desires seeing that the laws governing the filling of nomination papers to the office of Mayor of the City of DeKalb, Illinois (the "City") are properly complied with and that only qualified candidates have their names appear on the ballot as candidates for the said office; and, therefore, Objector makes the following objections to the nomination papers of Linh Nguyen, Bao Linh Tran Nguyen (the "Candidate" or "Respondent") as a candidate for nomination to the office of Mayor of the City, files this petition, and states that Candidate's nomination papers are insufficient in law and in fact for the following reasons:

Candidate's nomination papers are not filed within the time provided by law for an "independent" candidate for the office of Mayor of the City. See 10 ILCS 5/10-6 ("Except as otherwise provided in this Code, certificates of nomination and nomination papers for the nomination of candidates for the other offices of political subdivisions to be filled at regular elections other than the general election shall be filed with the local election official of such subdivision: (2) not more than 141 nor less than 134 days prior to the consolidated election[.]"). A true and correct copy of the Candidate's nomination papers are attached hereto as Exhibit A and are incorporated herein by reference. Candidate's nomination papers were purportedly filed on October 25, 2024. For the 2025 consolidated election on April 1, 2025, Candidate's nomination papers as an independent candidate for the office of Mayor of the City shall be filed not before November 12, 2024 later than November 18, (https://www.cityofdekalb.com/DocumentCenter/View/18092/2025-PreFiling-Period-Notice-Website, last visited Oct. 30, 2024).

Candidate cannot be a "nonpartisan" candidate for the office of Mayor of the City because the City has partisan elections for its officers. If Candidate is an "independent" candidate for the office of Mayor of the City, then Candidate's nomination papers are not filed within the time provided by law because Candidate's nomination papers were purportedly filed "more than 141 ... days prior to the consolidated election[.]" See 10 ILCS 5/10-6. Therefore, Candidate's non-compliance with the mandatory provisions for filing Candidate's nomination papers should void the purported filing of Candidate's nomination papers and disqualify Candidate from the office of Mayor of the City. See *id.*; *Daniels v. Cavner*, 404 Ill. 372, 380 (1949).

- 2. If Candidate is running under a party affiliation, Candidate's nomination papers fail to state the Candidate's political party in violation of the mandatory requirements of 10 ILCS 5/10-2, 10 ILCS 5/10-4, and 10 ILCS 5/10-5.
- 3. If Candidate is running under a party affiliation, Candidate's nomination papers fail to show that the Candidate was nominated by such a party in violation of the mandatory requirements of 10 ILCS 5/7-2, 10-2.

And

Candidate's nomination papers fail to consistently state Candidate's "given name" in violation of 10 ILCS 5/10-4 and 10 ILCS 5/10-5.1. The Candidate's statement of candidacy gives the Candidate's name as "Linh Nguyen", but it is also signed and sworn by the Candidate under the name "Bao Linh Tran Nguyen". The Candidate's loyalty oath gives the Candidate's name as "Bao Linh Tran Nguyen". The Candidate's petition papers give the Candidate's name as "Linh Nguyen", but the Candidate's circulator affidavit gave the Candidate's name as "Bao Linh Tran Nguyen". See, e.g., p. 10. Upon information and belief, the name "Linh Nguyen" is not the Candidate's given name, an initial, commonly known nickname, or combination thereof. See 10 ILCS 5/10-5.1. Furthermore, the lack of continuity and consistency in the Candidate's name in her nomination papers is confusing to the persons who signed Candidate's nominating petitions because they might not have known who they were nominating. See, e.g., Catherine v. Chalmers, No. 99-EB-ALD-106 (Chi. Electoral Bd. 1999). In addition, the Statement of Candidacy provides that "Lin Nguyen" is the candidate's name, however, the person signing the Statement of Candidacy is "Bao Linh Tran Nguyen." This inconsistency gives rise to confusion for the County Clerk's task of designation on the Ballot as to the proper name of the candidate. Thus, Candidate's failure to consistently state her given name on her nomination papers should require Candidate's disqualification. See Shannon-Di-Cianni v. Du Page County Officers Electoral Bd., 2020 IL App (2d) 200027, ¶ 21.

WHEREFORE, Objector prays that the purported nomination papers of Linh Nguyen as a candidate for nomination to the office of Mayor of the City of DeKalb, Illinois be declared by this Electoral Board to be insufficient and not in compliance with the laws of the State of Illinois, and that the Candidate's name be stricken, and that this Electoral Board enter its decision declaring that the name of Linh Nguyen as a candidate for the office of Mayor of the City of DeKalb, Illinois BE NOT PRINTED on the OFFICIAL BALLOT for the consolidated elections.

### CODE OF FAIR CAMPAIGN PRACTICES

There are basic principles of decency, honesty, and fair play that every candidate for public office in the State of Illinois has a moral obligation to observe and uphold, in order that, after vigorously contested but fairly conducted campaigns, our citizens may exercise their constitutional right to a free and untrammeled choice and the will of the people may be fully and clearly expressed on the issues.

### THEREFORE:

- (1) I will conduct my campaign openly and publicly, and limit attacks on my opponent to legitimate challenges to his record.
- (2) I will not use or permit the use of character defamation, whispering campaigns, libel, slander, or scurrilous attacks on any candidate or his personal or family life.
- (3) I will not use or permit any appeal to negative prejudice based on race, sex, sexual orientation, religion or national origin.
- (4) I will not use campaign material of any sort that misrepresents, distorts, or otherwise falsifies the facts, nor will I use malicious or unfounded accusations that aim at creating or exploiting doubts, without justification, as to the personal integrity or patriotism of my opposition.
- (5) I will not undertake or condone any dishonest or unethical practice that tends to corrupt or undermine our American system of free elections or that hampers or prevents the full and free expression of the will of the voters.
- (6) I will defend and uphold the right of every qualified American voter to full and equal participation in the electoral process.
- (7) I will immediately and publicly repudiate methods and tactics that may come from others that I have pledged not to use or condone. I shall take firm action against any subordinate who violates any provision of this Code or the laws governing elections.
