#### NAV and Receivable Calculations Under Development

The IPOPIF [AR 2022-01 Valuation and Cost Rule.pdf](#), stipulates that subsequent to transfer of investment assets from all Article 3 Funds, the Net Asset Value (NAV) for each Participating Police Pension Fund will include a final true-up allocation of all costs paid using funds from the total consolidated IPOPIF investment portfolio for the period January 1, 2023, through December 31, 2024, and all loan payments made to the Illinois Finance Authority subsequent to January 1, 2023. These adjustments are expected to be completed in the first quarter of 2025.

These adjustments are expected to be completed in the first quarter of 2025.

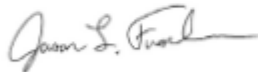
As requested, we are providing a Letter of Engagement for actuarial services for the City of DeKalb Police Pension Plan. These services will include the following:

- Preparation of the annual actuarial valuation commencing with the January 1, 2025 measurement date. Foster & Foster, Inc. will provide a report containing the tax levy amount and the GASB Statement No. 67 and 68 financial disclosure information as of December 31, 2024. The annual fee for this service is \$7,725.
- A meeting with City Staff or Council to discuss the results and answer outstanding questions. This is included in annual valuation fee.
- If requested, we will perform true cost calculations for a fee of \$450 each.

The fees for these services are subject to a 3% annual increase beginning with the 2026 fiscal year-end.
