# DeKalb Police Arrest Two for the October 31st, 2017 Shooting

The DeKalb Police announced today that two offenders have been charged, who are alleged to have been involved in an October 31<sup>st</sup> incident where several shots were fired in to an occupied vehicle, in the 800 block of North Annie Glidden Road. A 28-year-old female sustained a gunshot wound to her leg, while in the vehicle.

Khalief McAllister, 20, of DeKalb and Anthony Rogers, 19, of Aurora, IL are being held in DeKalb County Jail. Warrants for their arrest were issued on April 6<sup>th</sup>, 2018 for attempt first degree murder and bond was set at \$50,000 dollars. Both McAllister and Rogers were already incarcerated in the DeKalb County Jail in regard to the October 20<sup>th</sup> shooting that occurred on Greenbrier Road.

On October 31, 2017 (Halloween), the DeKalb Police Department, Northern Illinois University Police Department, the DeKalb County Sheriffs Department, and the DeKalb Fire Department responded to the 800 block of North Annie Glidden Road in reference to a shooting. As officers arrived on scene, they observed a vehicle that crashed through a fence and struck a utility pole. Police and paramedics rendered aid to a victim who was shot, who was transported to the hospital where the victim was treated and released. Detectives processed the crime scene for evidence and collected numerous shell casing. The offenders shot into an occupied car and also directed gunfire into nearby apartments.

With the assistance from witnesses and video surveillance, suspects were identified and arrested on April 6<sup>th</sup>, 2018. The DeKalb Police and the DeKalb County States Attorney's Office continue to investigate and anticipate further arrest(s).

#### ARRESTED:

# Khalief D. McAllister, 20 years old, DeKalb, IL

CHARGES: Attempt First Degree Murder, Aggravated Battery, Armed Violence, Aggravated Discharge of a Firearm, Aggravated Unlawful Use of a Weapon, and Mob Action

Anthony Rogers, 19 years old, Aurora, IL

CHARGES: Attempt First Degree Murder, Aggravated Battery, Armed Violence, Aggravated Discharge of a Firearm, Aggravated Unlawful Use of a Weapon, Mob Action, and Unlawful Possession of a Firearm by a Street Gang Member.

### **UPDATE:**

In addition, Khalief McAllister was also charged in connection to the October 8<sup>th</sup>, 2017 shooting that occurred in the 800 block of Greenbrier Road. Khalief McAllister and Michael Distasio followed the victims from Greenbrier Road to Russell Road. When the victims questioned Distasio and McAllister as to why there following them, Distasio pulled out a handgun and began firing. McAllister was charged with Aggravated Discharge of a Firearm regarding this shooting, bond was set at \$10,000 dollars. Michael Distasio was previously charged in connection with this investigation and is currently incarcerated at the DeKalb County Jail. No further arrests are expected in this investigation
