AUTHORIZING AN ARCHITECTURAL IMPROVEMENT PROGRAM (AIP) ECONOMIC INCENTIVE FOR THE EGYPTIAN THEATER, 135 N. SECOND STREET, DEKALB, ILLINOIS IN THE AMOUNT OF \$4,314.

PASSED: MARCH 8, 2021

WHEREAS, the City of DeKalb (the "City") is a home rule unit pursuant to Article VII, Section 6(a) of the 1970 Illinois Constitution and may exercise any power and perform any function pertaining to its government and affairs; and

WHEREAS, the City has previously created the Architectural Improvement Program (AIP) Grant process and seeks to approve of an AIP Grant for the Egyptian Theatre for the property located at 135 N. Second Street, DeKalb, Illinois in the amount of \$4,314.00.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City of DeKalb approves an AIP Grant in the amount of \$4,314.00 for the Egyptian Theatre (the "Owner") for use at the property located at 135 N. Second Street, DeKalb, Illinois ("the Property"), subject to the following provisions:

- 1. Given the small scope of the requested grant, the City waives formal compliance with the requirements of the AIP process except as outlined herein. The City also waives requirement of a promissory note or mortgage to secure the AIP Grant.
- 2. Payment of the AIP Grant shall be as a reimbursement to Owner, after Owner provides proof of incurring costs of not less than \$8,628.00 on renovation at the Property consisting of: Americans with Disabilities Act (ADA) compliance on the stage access wheelchair lift. The AIP Grant shall be in the amount which is the lesser of: a) \$4,314.00; or b) the amount which is not more than 50% of the total project costs.
- 3. The Owner agrees to provide documentation of the project and incurred costs, inclusive of full lien waivers, invoices, and adequate evidence of payment, all in form and content acceptable to the City Manager or designee, prior to payment of the reimbursement.
- 4. The Owner agrees, as a condition of accepting the funds contemplated herein, to maintain the improvements funded by this AIP Grant for a period of not less than five (5) years. The AIP Grant funds provided herein shall be considered partially forgiven by 20% (1/5) each year on the anniversary of their payment to Owner, until fully forgiven on the fifth anniversary of such payment. Should Owner fail to maintain the improvements for the full five-year period, then Owner shall be responsible for reimbursing the City in an amount equivalent to the then-unforgiven portion of the AIP Grant (e.g., if the Owner fails to maintain the improvements in the 4th year, the Owner shall reimburse the City for forty percent (40%) of the AIP Grant amount.
- 5. The Owner agrees to indemnify, defend, and hold harmless the City from any claims or damages arising out of or relating to the AIP Grant or the work to be performed by Owner. The Owner shall provide the City with a certificate of insurance naming the City as additional primary insured with waiver of right of subrogation prior to commencement of work. The Owner agrees and acknowledges that the funding contemplated herein is payable to Owner only and may not be assigned or transferred to any other party. The City shall not make direct payments

to any contractors or materialmen, and the City's obligation to provide funding shall not accrue until Owner provides the City with evidence of lien waivers from all contractors and materialmen providing labor or materials for the project.

- 6. The Owner shall complete all related work in a good and workmanlike fashion, in accordance with all applicable codes and ordinances, and after having obtained all required permits. All work shall be subject to inspection and approval by the City, once completed.
- All work shall be completed within one calendar year of the date of approval of this Resolution, or the funding approval contemplated herein shall terminate and this Resolution shall be of no further force or effect.
- 8. Owner shall provide a letter to the City, acknowledging and agreeing to the terms and conditions of this Resolution, prior to the City's issuance of payment to Owner.

SECTION 2: The City Clerk or the Executive Assistant shall be authorized and directed to attest the Mayor's Signature and shall be effective thereupon, following execution as outlined in the preceding section.

City Manager Bill Nicklas,

I am contacting you to request AIA funding support for a sudden and unexpected project regarding ADA accessibility at the Egyptian Theatre.

On December 10, 2020 an elevator inspector from the State Fire Marshall office stopped by the Egyptian Theatre unannounced to look at our wheelchair lift that goes from our main floor up to the stage (roughly 4 feet). This lift has been here since 1998 serving performers and guests in wheelchairs that need access to the stage.

Despite being registered with the State of Illinois as required and passing previous inspections, the inspector condemned the lift and tagged it out of service. His reasoning was because he said this lift no longer meets the commercial building code requirements for wheelchair lifts. After multiple attempts of asking for it to be grandfathered or to request a variance, no flexibility was provided.

We inquired with multiple companies about modifying the lift to meet the code he was requiring us to meet and they all said it couldn't be done with this lift.

Our only options at this point is to replace the lift or go without a lift which would prohibit multiple individuals a year from accessing the stage. We talked with an architect and there is not enough room anywhere near the stage to install a wheelchair ramp nor are there any other locations around the stage to install a different wheelchair lift.

The only option to still provide wheelchair access to the stage, which is our priority, is to purchase a commercial portable wheelchair lift. After much research, we found two companies that make these lifts.

AmeriGlide Hercules 750 Portable (with delivery) \$8,628.00 Ascension Protégé Lift 5442 P (with delivery) \$23,636.00 Ascension Virtuoso 5460 P (with delivery) \$30,998.50

Our desire is to purchase the AmeriGlide Hercules unit for \$8,628.00.

EGUPTIAN THEATRE 135 N 2ND STREET - DEKALR, IL CO115 WWW.EGUPTIANTHEATRE.ORG As you are aware, we were closed March 13, 2020 due to the COVID-19 mitigation efforts in the State of Illinois. We were allowed to reopen in October 2020 with extremely limited capacity and then closed down again in November 2020 by the State. Late January 2021 we were allowed to open again with extremely limited capacity. This has allowed us to host some ticketed tours, movies, and private events.

For March-December 2020 our estimated loss in revenue was \$600,000. Thus far, we have been fortunate to receive a number of COVID relief grants and donations from the community. Every month has been a challenge financially to keep the lights on. While things are looking more optimistic, it is still estimated that things for our industry won't return to "normal" until 2022. We have continued to cut every expense we can while applying for grants and fundraising to sustain operations.

Also, in 2020, we completed our expansion project that started May 1, 2019 and was generously supported by the City of DeKalb and the community. Due to many unknown surprises during the construction project on this 90+ year old building and very much due to the dramatic impact of COVID-19, the project ended over budget. The complete project totaled \$6.5 million. We have about \$400,000 of that amount that we are continuing to fundraise for and apply for grants.

As a result of all of these circumstances, we are not in the financial position to replace the wheelchair lift to the stage as is being required by the State of Illinois. We would like to ask the City of DeKalb for an AIA grant in the amount of \$4,314.00 in order to purchase a new wheelchair lift. We are exploring other grant opportunities to cover the other 50% that the AIA grant won't cover.




