RESOLUTION 2021-036

AUTHORIZING THE TRANSFER AND ASSIGNMENT OF AN AGREEMENT FROM ILLINOIS CONVENIENCE & SAFETY CORPORATION TO VIEW CHICAGO TRANSIT, LLC AS IT PERTAINS TO THE PLACEMENT OF BUS SHELTERS ALTONG TRANSIT ROUTES IN DEKALB.

PASSED: APRIL 26, 2021

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government which may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the City and Illinois Convenience & Safety Corporation ("IC&SC") are parties to an agreement pertaining to the installation and maintenance of bus shelters along the City's transit routes (the "Agreement"); and

WHEREAS, the City, IC&SC, and View Chicago Transit, LLC ("VC Transit") negotiated an assignment, assumption and novation agreement in the form attached hereto and incorporated herein as Exhibit A (the "Assignment Agreement") to assign the Agreement from IC&SC to VC Transit and to have VC Transit assume or replace IC&SC's duties under the Agreement; and

WHEREAS, the City's corporate authorities find that approving the Assignment Agreement is in the City's best interests and promotes the public health, safety and welfare.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities authorize, approve, and ratify the Assignment Agreement including, but not limited to, the City Manager's execution of the Assignment Agreement and all other acts performed by City staff to effectuate the Assignment Agreement.

SECTION 2: This Resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provisions of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that to the extent that the terms of this Resolution should be inconsistent with any non-preemptive state law, that this Resolution shall supersede state law in that regard within its jurisdiction.

SECTION 3: This resolution shall be in full force and effect from and after its passage and approval as provided by law.

EXHIBIT A (Assignment, Assumption and Novation Agreement with IC&SC and VC Transit)

ASSIGNMENT, ASSUMPTION AND NOVATION AGREEMENT

This Assignment, Assumption and Novation Agreement (this "Assignment Agreement") is entered into to be effective as of this day of day of 2021 (the "Effective Date"), by and between Eagle Advertising Co., a Michigan corporation D/B/A Illinois Convenience & Safety Corp ("IC&SC" or "Assignor"), View Chicago Transit, LLC ("VC Transit" or "Assignee"), an Illinois limited liability company, and the City of DeKalb (the "City"), an Illinois municipal corporation, who are collectively referred to as the "Parties" or individually as a "Party".

RECITALS

WHEREAS, Assignor and the City are parties to that certain Agreement dated January 17, 2005, which Agreement was amended August 12, 2019 by Resolution 219-121 and pertains to the installation and maintenance of bus shelters along the City's transit routes (collectively, the "Agreement"); and

WHEREAS, Assignor desires to transfer and assign to Assignee its rights, duties, and obligations under the Agreement accruing after the Effective Date; and

WHEREAS, Assignor desires to be discharged from its duties under the Agreement accruing from and after the Effective Date; and

WHEREAS, Assignee desires to acquire the Agreement on the terms and conditions provided herein; and

WHEREAS, as of the Effective Date of this Assignment Agreement, the City is willing to release Assignor from its obligations under the Agreement accruing on or after the Effective Date and to consent to Assignor assigning the Agreement to Assignee; and

NOW, THEREFORE, in consideration of the mutual promises and covenants contained herein, the sufficiency of which the Parties mutually acknowledge, the Parties agree as follows:

- 1. The recitals to this Assignment Agreement are true, correct, material, adopted and incorporated herein.
- 2. Assignor hereby assigns, transfers, conveys and delivers to Assignee, effective as of the Effective Date, all of Assignor's right, title and interest in, to and under the Agreement, free and clear of all liens and encumbrances (the "Assignment"). Assignor represents and warrants to and covenants with Assignee that: (a) Assignor owns the entire interest of IC&SC under the Agreement; (b) the right, title and interest in and to the Agreement assigned to Assignee hereby is free and clear of all liens, charges and encumbrances and may be assigned to Assignee without the consent of any third party other than the City being required; and (c) Assignor shall continue to be responsible for and shall perform and satisfy its obligations under the Agreement insofar as such obligations relate to the period prior to the Effective Date and shall indemnify, defend and hold Assignee harmless for all such obligations or any other claims relating thereto and accruing prior to the Effective Date.

- 3. Assignee accepts the Assignment and assumes the performance of all the terms, covenants and conditions of the Agreement on the part of IC&SC which are to be performed or which arise from and after the Effective Date, but not otherwise. Assignor shall promptly notify Assignee in writing if any claim is made against Assignor with respect to any matter which Assignee has agreed to assume in this Assignment Agreement, specifying the nature and details of such claim. Assignor shall cooperate fully with Assignee and its counsel and attorneys in the defense against such claim in accordance with their judgment and discretion, and Assignor shall not pay or settle any such claim without Assignee's prior written consent.
- 4. The Parties agree that this Assignment Agreement shall constitute a novation of the obligations of Assignor under the Agreement which arise from and after the Effective Date, but not otherwise. Accordingly, all of the rights, duties, and obligations of Assignor under the Agreement are extinguished as of the Effective Date, but only to the extent that they have been assumed by Assignee under this Assignment Agreement. The City recognizes Assignee as Assignor's successor in interest in and to all of Assignor's rights, duties, and obligations in, to, and under the Agreement and hereby consents to the Assignment.
- 5. This Assignment Agreement shall inure to the benefit of and be binding upon the Parties and their successors and assigns from and after the Effective Date.
- 6. All notices under the Agreement shall henceforth be given as follows, to be effective when personally delivered, the business day after being sent by recognized overnight courier marked for overnight delivery, or upon email transmission, provided the sender receives a so called delivery receipt or the recipient acknowledges receipt, in each case addressed as follows:

Except as may otherwise be provided herein, the Agreement shall continue in full force and effect and Assignor and the City hereby represent and warrant to Assignee that the Agreement is in full force and effect, and each Party represents and warrants to the other Parties that it has full power and authority to enter into this Assignment Agreement and that it is not aware of any breach or fact or circumstance that with the giving of notice and/or the passage of time would constitute a breach of the Agreement by either of the other Parties.
- 8. If either Assignee or Assignor, or their respective successors or assigns, file suit to enforce the obligations of the other party under this Assignment Agreement, the prevailing party shall be entitled to recover the reasonable fees and expenses of its attorneys.
- 9. This Assignment Agreement may be signed in any number of counterparts each of which shall be deemed to be an original and all of which taken together shall constitute one and the same instrument. Any such execution may be by facsimile or other electronic signature.




