AUTHORIZING PAYMENT IN THE AMOUNT OF \$21,558.60 TO MACON COUNTY LAW ENFORCEMENT TRAINING CENTER FOR THREE POLICE OFFICERS TO ATTEND THE BASIC LAW ENFORCEMENT ACADEMY.

WHEREAS, the City of DeKalb (the "City") is a home rule unit of local government which may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

WHEREAS, the Illinois Law Enforcement Training and Standards Board (the "ILETSB") recently transitioned from directly paying the City's costs of a new police officer's basic academy training to annual reimbursements of said costs; and

WHEREAS, the City recently incurred costs in the amount of \$21,558.60 for three new police officers to attend basic academy police training at Macon County Law Enforcement Training Center; and

WHEREAS, the City has sufficient funds to pay for said costs from the Police Department Patrol Training & Travel Fund and further anticipates that said costs should be reimbursed by ILETSB; and

WHEREAS, the City's corporate authorities find that it is in the City's best interests to approve payment to Macon County Law Enforcement Training Center in an amount not to exceed \$21,558.60; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:

SECTION 1: The City's corporate authorities approve, authorize, and direct the City Manager or his designee to provide payment to Macon County Law Enforcement Training Center in an amount not to exceed \$21,558.60 from the Police Department Patrol Training & Travel Fund in full satisfaction of Invoice 21-554, and further direct City staff to pursue reimbursement of said costs from the State of Illinois.

SECTION 2: This resolution shall be in full force and effect from and after its passage and approval as provided by law.
