

**AUTHORIZING THE PURCHASE OF THIRTY (30) POLICE PORTABLE  
RADIOS FROM J&K COMMUNICATIONS AT A COST NOT TO EXCEED  
\$91,000.**

**WHEREAS**, the City of DeKalb (the "City") is a home rule unit of local government and may exercise any power and perform any function pertaining to its government and affairs pursuant to Article VII, Section 6, of the Illinois Constitution of 1970; and

**WHEREAS**, the City's Police Chief recommends approving the bid attached and incorporated as Exhibit A (the "Bid") to purchase 30 police portable radios from J&K Communications in a total amount not to exceed \$91,000; and

**WHEREAS**, the City's corporate authorities find that approving the Bid is in the City's best interests for the protection of the public health, safety, and welfare; and

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF DEKALB, ILLINOIS:**

**SECTION 1:** The recitals to this resolution are true, material, adopted and incorporated as Section One to this Resolution.

**SECTION 2:** The City's corporate authorities approve the Bid. The City's corporate authorities authorize and direct the City Manager to: (1) negotiate and execute an agreement with J&K Communications for the Bid; and (2) take all necessary acts to effectuate the award of the Bid.

**SECTION 3:** This resolution and each of its terms shall be the effective legislative act of a home rule municipality without regard to whether such resolution should (a) contain terms contrary to the provision of current or subsequent non-preemptive state law, or (b) legislate in a manner or regarding a matter not delegated to municipalities by state law. It is the intent of the City's corporate authorities that if this resolution is inconsistent with any non-preemptive state law, this resolution shall supersede state law in that regard within its jurisdiction.

**SECTION 4:** This resolution shall be in full force and effect from and after its passage and approval as provided by law.

**PASSED BY THE CITY COUNCIL** of the City of DeKalb, Illinois, at a Regular meeting thereof held on the 14<sup>th</sup> day of April 2025 and approved by me as Mayor on the same day.
