SCHEDULE O "FIRE LANE ZONES"

Revision Date: 1-20-04

In accordance with Section 51.18-5, the following are designated as fire lane zones.

ALLEY BEHIND 363, 323 AND 317 EAST LINCOLN HIGHWAY.

Beginning at the Northeast corner of the building at 323 East Lincoln Highway and continuing West 130 feet.

Beginning at the Southwest corner of the "inner alley" and continuing North 80 feet. (90-23)

722 NORTH ANNIE GLIDDEN ROAD AND 819 RUSSELL ROAD.

Any area not otherwise designated and marked a parking space shall be posted as a fire lane, including all entrances and drives to and from any designated parking area. (89-92)

Areas expressly excluded from parking include all entrances to parking lots, driveways less than 30 feet in width and in front of and adjacent to all fire hydrants.

1015 BLACKHAWK DRIVE.

Beginning at the Southwest corner of the building and continuing East 103 feet along the South frontage and ending at the Southeast corner of the building. (88-87)

Beginning at the Southeast corner of the building and continuing North 126 feet along the East frontage ending at the Northeast corner of the building.

Beginning at the Northwest corner of the building and continuing East along the North frontage 90 feet.

CHESEBRO SCHOOL, NINTH AND GARDEN STREET.

Beginning at the Taylor Street rear entrance and continuing North 215 feet along drive ending at the Southeast corner of Chesebro School. (88-87)

CLINTON ROSETTE MIDDLE SCHOOL, 650 NORTH FIRST STREET.

Beginning at the First Street South entrance drive, continuing North 716 feet, ending at First Street North entrance drive. (88-87)

1455 COUNTY FARM ROAD

Beginning at the Northeast corner of the building, the fire lane shall extend 130 feet, ending at the Southeast corner of the building.

Aligning with the center of the West end of the building, the fire lanes shall be parallel to the building and 30 feet wide.

900 CRANE DRIVE - NORTH AND SOUTH TOWER.

Beginning at the Southwest corner of the North Tower and continuing East 135 x 18 feet in width and ending at the sidewalk. (89-44)

Beginning approximately in the middle of the North Tower, on the South Side, continuing South along the sidewalk 125 x 18 feet in width, ending at the sidewalk on the North side of the South Tower.

Beginning at the Northwest corner of the South Tower and continuing East 135 x 18 feet, ending at the sidewalk.

Beginning at the Northwest corner of the North Tower and continuing East 188 x 18 feet in width along Crane Drive.

Beginning at the Southwest corner of the South Tower and continuing North 60 x 18 feet in width.

DEKALB HIGH SCHOOL, 1515 SOUTH FOURTH STREET, FRONT ENTRANCE.

Beginning at the Barb Boulevard East entrance drive, following the parking lot curb fronting the building for 499 feet ending at the Southwest corner of the building. (01-07)

DEKALB HIGH SCHOOL, 1515 SOUTH FOURTH STREET, REAR ENTRANCE.

Beginning at the South Fourth Street entrance drive, North side, for a distance of 286 feet to the West. (88-87, 01-07)

Beginning at the South Fourth Street entrance drive, South side, for a distance of 249 feet to the West. (01-07)

Beginning at the Southeast corner of the curb on the East side of the swimming pool building for a distance of 95 feet to the North. (01-07)

Beginning at the Northwest corner of the Greenhouse building, following the parking lot curb for a distance of 374 feet to the South and West. (01-07)

809 EDGEBROOK DRIVE.

Beginning at the Southwest corner of the Edgebrook Street entrance drive and continuing North 90 feet. (90-23)

Beginning at the Southeast corner of the Edgebrook Street entrance drive and continuing North 90 feet.

Beginning at the fire hydrant on the North side of the parking area and continuing East 10 feet and West 10 feet, totaling 20 feet.

235 NORTH FIRST STREET.

Beginning at the Southeast corner of the building, continuing West along the South side of the building 91 feet.

Beginning at the entrance drive on North First Street on the South side of the drive and continuing West 135 feet.

Beginning at the Southwest corner of the building and continuing North along the West side of the building 45 feet. (90-23)

1401 SOUTH FOURTH STREET.

Beginning at the Northwest corner of building continuing South 230 feet and ending at the Southwest corner of the building.

Beginning at the Northeast corner of building continuing South 318 feet and ending at the Southeast corner of the building. (89-44)

926 GREENBRIER.

Beginning at the Northwest corner of the property continuing West along the fence 220 feet, ending at the entrance drive. (88-87)

926 GREENBRIER ROAD.

Beginning at the Southern edge of the sidewalk adjacent to Greenbrier and continuing South for 170 feet. The fire lane shall be 23 feet in width. (95-137)

2944 GREENWOOD ACRES DRIVE.

Beginning at the Northeast corner of the North wing and continuing West 122 feet. (90-23)

Beginning at the Northeast corner of the North wing and continuing South along the East frontage 330 feet and ending at the Southeast corner of the East wing.

Beginning at a point approximately 86 feet South of the Northwest corner of the North wing and continuing South 122 ft.

830 GROVE STREET.

Beginning at the center of the North frontage of the Salvation Army Building and continuing West and East for 24 feet in each direction, a total of 48 feet.

210 GURLER ROAD.

Beginning at the concrete curb on the South side of the Entrance to the Courtyard and continuing East for a distance of 30 feet; then South for a distance of 53 feet; then East for a distance of 158 feet; then North for a distance of 159 feet. Also, a Fire Lane is established around the entire perimeter of the island located in the center of the Courtyard. (00-92)

904 HILLCREST DRIVE.

Beginning at the West Drive entrance, starting at the drive entrance on East side of the drive, continuing South 50 feet. (89-101, 91-95)

Beginning on the West side of the same drive continuing South 112 feet.

Beginning at the Southwest corner of the building continuing South 25 feet.

1027, 1023, 1021, 1017, 1015, 1013 AND 1011 WEST HILLCREST.

Beginning 26 feet South of the frontage of the building complex at the Southwest corner of 1027 West Hillcrest and continuing East for a distance of 375 feet and terminating at the Southeast corner of 1011 West Hillcrest. (95-111)

HOPKINS PARK SWIMMING POOL, 1403 SYCAMORE ROAD.

Beginning at the Northeast corner of the West parking lot and continuing West 103 feet along the North end of the same lot, ending at the Northwest corner of the parking lot.

Beginning at the Northwest corner of the East parking lot and continuing along the East frontage of the swimming pool 205 feet, ending at the Southeast corner on same parking lot. (88-87)

HUNTLEY MIDDLE SCHOOL, TAYLOR AND SEVENTH STREETS.

Beginning at the Taylor Street entrance drive and continuing South 186 feet. (88-87)

Beginning at the Seventh Street entrance drive and continuing West 195 feet.

Beginning at the Culver Street entrance drive and continuing North 245 feet.

Beginning at the Southeast corner of the rear parking lot and continuing West 100 feet.

Beginning at the Northeast corner of the rear parking lot and continuing West 100 feet.

301 INDUSTRIAL DRIVE.

Beginning on the East side of the yard along Industrial Drive at the North entry gate; starting on the North side of the drive and continuing South 26 feet ending at the South side of the same drive. (89-94)

Beginning on the East side of the yard along Industrial Drive at the South entry gate; starting on the North side of the drive and continuing South 17 feet ending at the South side of the same drive.

JEFFERSON ELEMENTARY SCHOOL, NORTH FIRST STREET AND McCORMICK DRIVE.

Beginning at the McCormick Drive entrance and continuing West along the curb 300 feet. (88-87)

Beginning at the entrance drive to the West parking lot and continuing West 150 feet.

LINCOLN ELEMENTARY SCHOOL, SOUTH SECOND AND SUNSET STREETS.

Beginning at the Sunset Street entrance continuing South 133 feet. (88-87)

810 WEST LINCOLN HIGHWAY.

Beginning at the Northeast corner of the entrance off Lincoln Highway and continuing South for a distance of 110 feet along the East side of the property line. (94-34)

1000 WEST LINCOLN HIGHWAY

Beginning at the Southwest corner of the building, in front of the fire department connection, and continuing North for a distance of 37 feet. Beginning at the fire hydrant near the Southwest corner of the building and continuing North for a distance of 13 feet.

1000 WEST LINCOLN HIGHWAY.

Beginning at the Northeast corner of the building and continuing South to the Southeast corner of the building, 100 feet. (90-38)

Beginning at the Southwest corner of the building and continuing North 37 feet.

Beginning at the fire hydrant West of the Southwest corner of the building, continuing North 13 feet.

1001 WEST LINCOLN HIGHWAY.

Beginning at the fire hydrant South of Building One, continuing West following the curb and then North, 75 feet. (89-44)

Beginning at the Northwest corner of Building Two, continuing South following the curb, 80 feet.

Beginning at the Northwest corner of Building Two, continuing East following the curb, 470 feet, ending at the Northeast corner of Building Three.

1004 AND 1010 WEST LINCOLN HIGHWAY.

Beginning at the Northwest corner of Building One, continuing South 102 feet ending at the Southwest corner of Building Two. (89-44)

Beginning at the Northwest corner of Building Three, continuing East 200 feet and ending at the Southeast corner of Building Six.

Beginning at the Southwest corner of Building Eight, continuing East 32 feet and ending at the Southeast corner of Building Eight.

Beginning at the Southeast corner of Building Eight, continuing North 65 feet and ending at the Northeast corner of Building Eight.

Beginning at the Northeast corner of Building Eight, continuing Northwest 130 feet and ending at the fire hydrant.

1311 WEST LINCOLN HIGHWAY.

Beginning at the Northeast corner of the building and continuing South 215 feet. (91-78, 91-95)

1315 WEST LINCOLN HIGHWAY.

Beginning at the Lincoln Highway entrance on the East side of the drive and continuing North 100 feet. (92-04)

Beginning at a point 292 feet North of Lincoln Highway, on the East side of the drive and continuing North 100 feet.

At the fire hydrant located off the Northeast corner of the building, no parking shall be permitted within a 20 foot radius of the hydrant.

1325 WEST LINCOLN HIGHWAY, BUILDINGS A AND B.

Building A: Beginning at the Southwest corner continuing North 255 feet and ending at the Northwest corner.

Building B: Beginning at the Fire Department connection, 18 feet North and 17 feet South of connection, totaling 35 feet. (89-44)

314 LINDEN PLACE.

Beginning from Linden Place on the North side of the West Driveway continuing 210 feet East. (04-01)

Beginning at the Northwest corner of the East building and continuing 100 feet to the East. (04-01)

LITTLEJOHN SCHOOL, NORTH TWELFTH STREET AND SCHOOL STREET.

Beginning at School Street entrance drive continuing North 147 feet. (88-87)

Beginning at the Thirteenth Street entrance and continuing West 310 feet ending at the Northwest corner of the parking lot.

Beginning at the Southwest corner of the parking lot continuing East 200 feet along North frontage of Littlejohn School, ending at the Southeast corner of the parking lot.

631 LUCINDA AVENUE.

Beginning at the driveway East of the building, starting at Lucinda and continuing North 215 feet. This fire lane is a minimum of 25 feet in width. (90-66)

401 NORMAL ROAD.

Beginning at the West driveway, starting at Lucinda and continuing North along the West side of the Drive 140 feet. This fire lane is a minimum of 20 feet in width. (90-66)

902 AND 914 RIDGE DRIVE.

Beginning at North entrance drive and continuing along the West curb side of the drive Southerly for 130 feet. (92-94)

919 WEST RIDGE DRIVE.

Beginning at the Northeast corner of the North Drive and continuing West 386 feet. (90-109)

423 RUSSELL ROAD.

Beginning at the Russell Road entrance drive and continuing East 181 feet ending at the Northeast corner of the apartment building.

Beginning at the Southeast corner of 423 Russell Road and continuing North 110 feet. (88-87)

1212 SOUTH SECOND STREET.

Beginning at the Southwest corner of the North Wing and continuing along the frontage of the building 147 feet. (90-38)

1320 SYCAMORE ROAD.

Beginning at the Northwest corner of the building and continuing East along the North frontage 390 feet and ending at the Northeast corner of the building. (90-23)

Beginning at the Southwest corner of the building and continuing East along the rear of the building 304 feet.

Beginning at the fire hydrant located in the drive at the rear of the building, 25 feet West and 25 feet East from the hydrant, a total of 50 feet.

1329 SYCAMORE ROAD.

Beginning at the Southwest corner of 1329 Sycamore Road and continuing North for 430 feet along the West frontage, ending at the Northwest corner of the same building. (88-87)

1616, 1700, 1704, 1714, 718, 1730 SYCAMORE ROAD.

Beginning at 1616 Sycamore Road, continuing North 637 feet, along entire frontage of above locations and ending at 1730 Sycamore Road. (89-44)

1734, 1740, 1754A, 1754B SYCAMORE ROAD.

Beginning at 1734 Sycamore Road, continuing East 136 feet, along entire frontage of the above locations, ending at 1754 B vacant. (89-44)

<u>1840, 1838, 1836, 1834, 1832, 1830, 1828, 1824, 1822, 1814 THROUGH 1820 SYCAMORE</u> ROAD.

Beginning at 1814 Sycamore Road, and continuing North 328 feet along the entire frontage of the above locations, and ending at 1840 Sycamore Road. (89-44)

2050 SYCAMORE ROAD.

Beginning at the first support column West of the main entrance and continuing East for a distance of 111 feet. (96-05)

2300 SYCAMORE ROAD.

Beginning at the North end of the sidewalk curb in front of the building and continuing South for a distance of 411 feet.

2500 SYCAMORE ROAD.

Beginning at the Southeast corner and continuing West 236 feet, ending 34 feet East of the Southwest corner.

Beginning at the Southwest corner and continuing North 98 feet, ending at the Northeast curb.

Beginning at the Fire Department connection, 25 feet East of connection, and 25 feet West of connection, totaling 50 feet.

Beginning at the Northwest corner of building, continuing East along the North frontage 770 feet, ending at the Northeast corner of building.

Beginning at the Fire Department connection located on the West exterior wall, 25 feet North of connection, and 25 feet South of connection, totaling 50 feet.

Beginning at the Fire Department connection located on the Southwest exterior wall, 25 feet West of connection, and 25 feet East of connection, totaling 50 feet.

Beginning at the Fire Department connection located on the Southeast exterior wall, 25 feet West of connection, and 25 feet East of connection, totaling 50 feet. (89-44)

2555 SYCAMORE ROAD.

Beginning at the curb adjacent to the Southeast corner of the building and continuing North for a distance of 320 feet and then continuing West along the curb adjacent to the Northeast corner of the building for a distance of 244 feet. (95-110)

2675 SYCAMORE ROAD

Beginning at the Southwest corner of the building and continuing North along the rear of the building 70 feet and ending at the Northwest corner of the same building. (90-23)

Beginning at the Southeast corner of the canopy, which is located to the front of the building and continuing North 25 feet and ending at the Northeast corner of the same canopy.

507 EAST TAYLOR STREET.

Beginning at the Taylor Street entrance drive and continuing South 204 feet along the West frontage of 507 East Taylor Street. (99-87)

TYLER ELEMENTARY SCHOOL, ALDEN CIRCLE.

Beginning at the North entrance drive, continuing South 360 feet ending at the South entrance drive. (88-87)

1110 AND 1120 VARSITY BOULEVARD.

Beginning at the Northwest corner of 1110 Varsity Boulevard, and continuing South 125 feet and ending at the Southwest corner of 1110 Varsity Boulevard. (88-87)

Beginning at the Northeast corner of 1120 Varsity Boulevard and continuing South 125 feet and ending at the Southeast corner of 1120 Varsity Boulevard.

1212 VARSITY BOULEVARD.

Beginning at the Southeast corner of Building No. 6, continuing West 250 feet ending at the Southwest corner of Building No. 5. (88-87)

Beginning at the Southwest corner of Building No. 4, continuing North 220 feet and ending at the Northwest corner of Building No. 4.

NOTE: All fire lanes are to be a minimum of 20 feet in width.
