TEMPORARY SPECIAL EVENT SIGN PERMIT APPLICATION

SPECIAL EVENTS - Certain temporary street signs and devices may be permitted for promoting special community activities, subject to the following provisions:

- ✓ A written request must be submitted to the Community Development Director or his/her designee seven (7) days prior to the date of the event; and,
- ✓ Special permit must be approved by the Community Development Director or his/her designee; and,
- ✓ A Picture of the Sign or Banner - as well as a Site Drawing showing the placement; and,
- ✓ Temporary Sign Permits shall be limited to a fourteen (14) consecutive day maximum exposure period. The issuance of a temporary sign permit shall not exceed six (6) times per calendar year per sponsor.
- ✓ Maximum size of 40 square feet for a Sign or Banner (except for Big Box Stores).
- ✓ Non-profit organizations can receive permission, via permit, for off premises temporary sign approval with **written permission from the property owner** of the proposed off-premises site where said temporary sign is to be located.

Definition of a Temporary Sign: Temporary signs shall include any sign, banner, pennant, valance, or advertising display constructed of wood, metal, cloth, canvas, light fabric, cardboard, wallboard, or other light material, with or without frames, where either by reason of construction or purpose the sign is intended to be displayed for a short period of time only. (ORD 08-52)
