

**AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS CHAPTER 51, "TRAFFIC," SECTION 51.17, "MUNICIPAL PARKING LOTS AND PARKING STALLS," SCHEDULE F, "LIMITED PARKING – CENTRAL BUSINESS DISTRICT" BY ADDING FOR FRANK VAN BUER PLAZA FOUR HOUR PARKING BETWEEN 6:00 P.M. TO 2:00 A.M.**

**BE IT ORDAINED BY THE CITY COUNCIL** of the City of DeKalb, Illinois as follows:

**Section 1.** That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.17, "Municipal Parking Lots and Parking Stalls" be amended by the following:

Amend Schedule F, Two Hours, Between 6:00 a.m. and 2:00 a.m.:

Delete Frank Van Buer Plaza (51 stalls). All stalls in the parking lot located North of Lincoln Highway, South of Locust Street, between Second and Third Streets.

**Section 2.** That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.17, "Municipal Parking Lots and Parking Stalls" be amended by the following:

Add to Schedule F, Two Hours, Between 6:00 a.m. to 6:00 p.m.

Frank Van Buer Plaza (51 stalls). All stalls in the parking lot located North of Lincoln Highway, South of Locust Street, between Second and Third Streets.

**Section 3.** That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.17, "Municipal Parking Lots and Parking Stalls" be amended by the following:

Add to Schedule F, Four Hours, Between 6:00 p.m. to 2:00 a.m.

Frank Van Buer Plaza (51 stalls). All stalls in the parking lot located North of Lincoln Highway, South of Locust Street, between Second and Third Streets.

**Section 4.** That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.

**Section 5.** That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

**Section 6.** Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: May 14, 2013. Effective date: May 24, 2013.
