

AMENDING THE MUNICIPAL CODE OF THE CITY OF DEKALB, ILLINOIS CHAPTER 51, "TRAFFIC," SECTION 51.13, "PARKING PROHIBITED," SCHEDULE C, "NO PARKING AT ANY TIME," IN VARIOUS LOCATIONS.

BE IT ORDAINED BY THE CITY COUNCIL of the City of DeKalb, Illinois as follows:

Section 1. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited," Schedule C, 1, "No Parking at Any Time," be amended by deleting the following:

~~**Garden Road, East side, from the North right-of-way line of Lucinda Avenue to a point 203 feet North.** (75-48, 84-85, 96-156, 03-17)~~

Section 2. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited," Schedule C, 1, "No Parking at Any Time," be amended by adding the following in the appropriate place:

Garden Road, East side, from the North right-of-way line of Lucinda Avenue to a point 254 feet North.

Section 3. That the Municipal Code of the City of DeKalb, Illinois, Chapter 51, "Traffic," Section 51.13, "Parking Prohibited," Schedule C, 1, "No Parking at Any Time," be amended by deleting the following in the appropriate place:

~~**Ridge Drive, south side, from Bayfield Drive to a point 278 feet east of the east right-of-way line of Normal Road.** (05-75)~~

Section 4. That the Municipal Code of the City of DeKalb, Illinois Chapter 51, "Traffic," Section 51.13, "Parking Prohibited," Schedule C, 1, "No Parking at Any Time," be amended by adding the following in the appropriate place:

Ridge Drive, South Side, from Bayfield Drive to a point 250 feet East of the East right-of-way line of Normal Road.

Section 5. That each section, paragraph, sentence, clause and provision of this ordinance is separable and if any provision is held unconstitutional or invalid for any reason, such decision shall not affect the remainder of this ordinance, nor any part thereof, other than that part affected by such decision.


Section 6. That except as to the amendments heretofore mentioned, all Sections of the Municipal Code of the City of DeKalb, Illinois shall remain in full force and effect.

Section 7. Upon its passage and approval according to law, this Ordinance shall, by authority of the City Council be published in pamphlet form. On the tenth day after the date of publication, this Ordinance shall be in full force and effect. Publication date: August 27th, 2013. Effective date: September 5, 2013.
