### Training

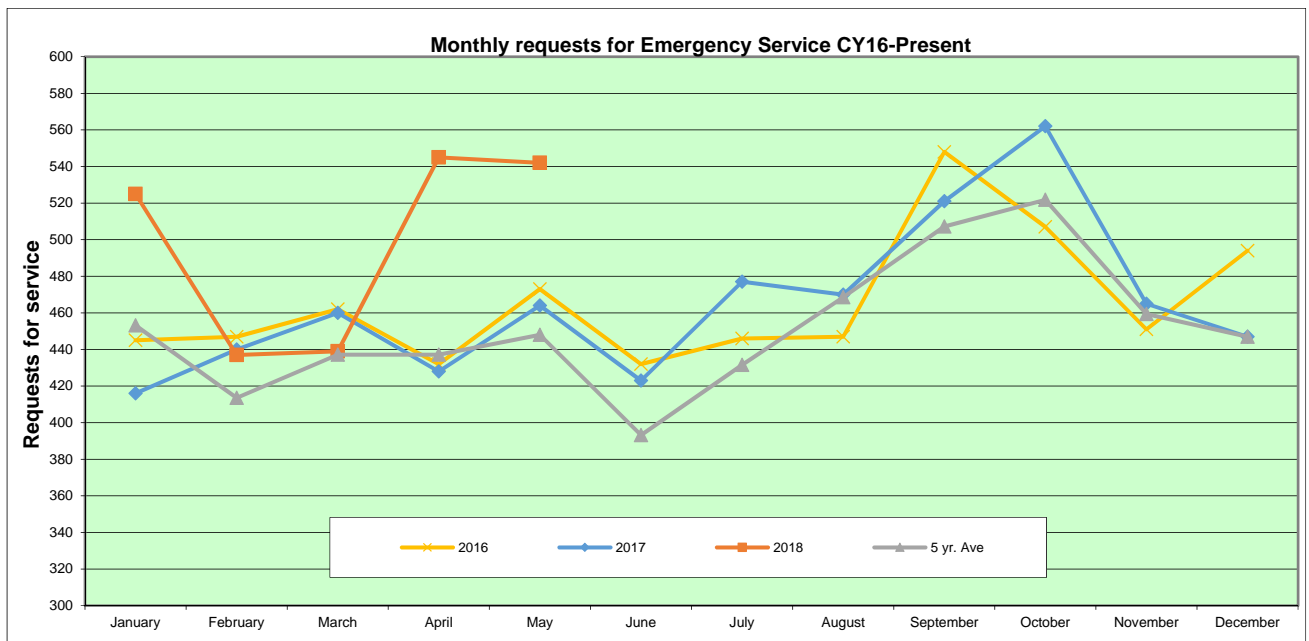
DeKalb firefighters spent 1,776.50 hours training during May 2018. Firefighters receive monthly fire training and bi-monthly hazardous materials and technical rescue training. Emergency Medical Technicians receive monthly EMS training.

### Operations

The DeKalb Fire Department responded to 542 incidents in May 2018. Emergency medical requests accounted for 376 (69.37%) of the monthly total. The remaining 166 (30.63%) of the incidents were fire/rescue related requests.

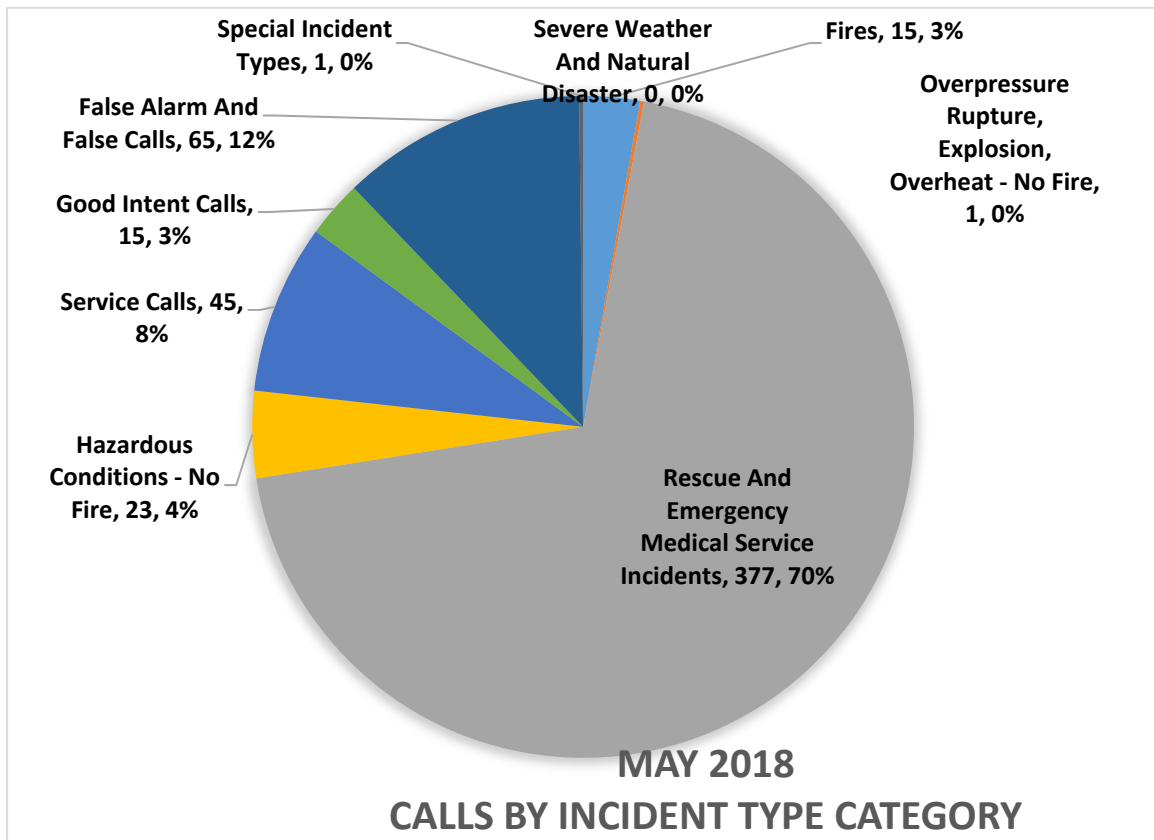
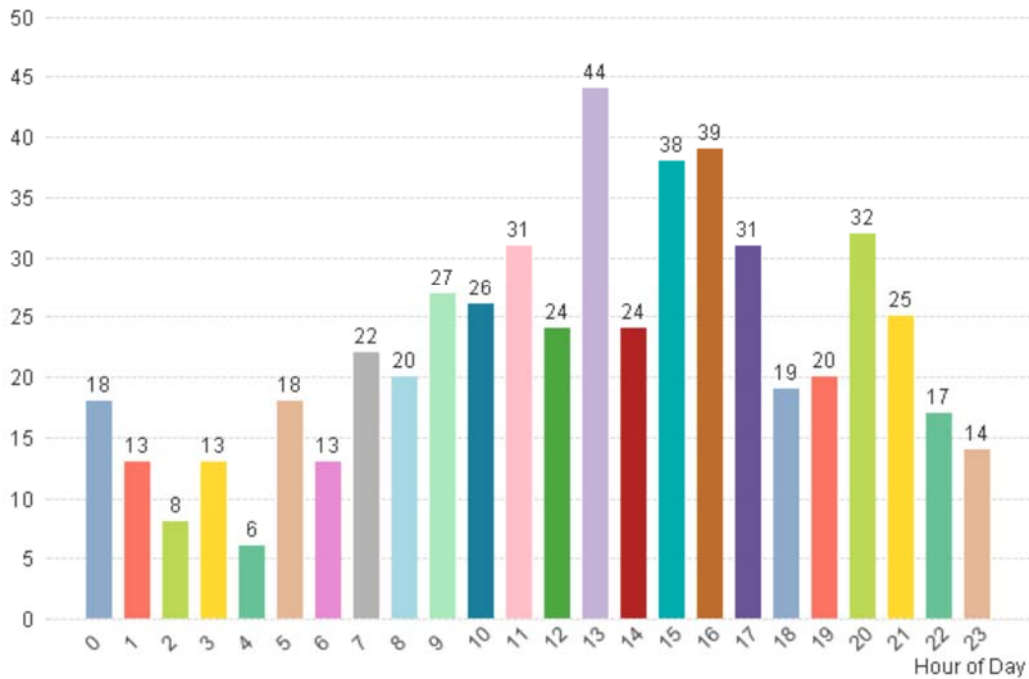
Mutual aid was provided to other communities on 24 incidents and was requested by DeKalb for 0 total incidents.

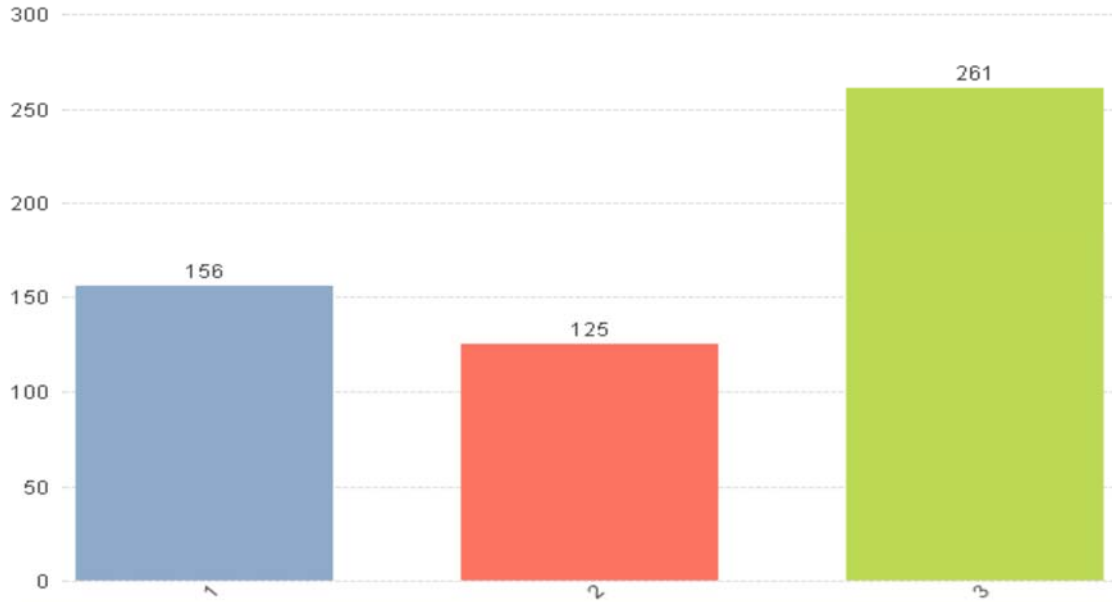
**Calls by Hour of the Day**

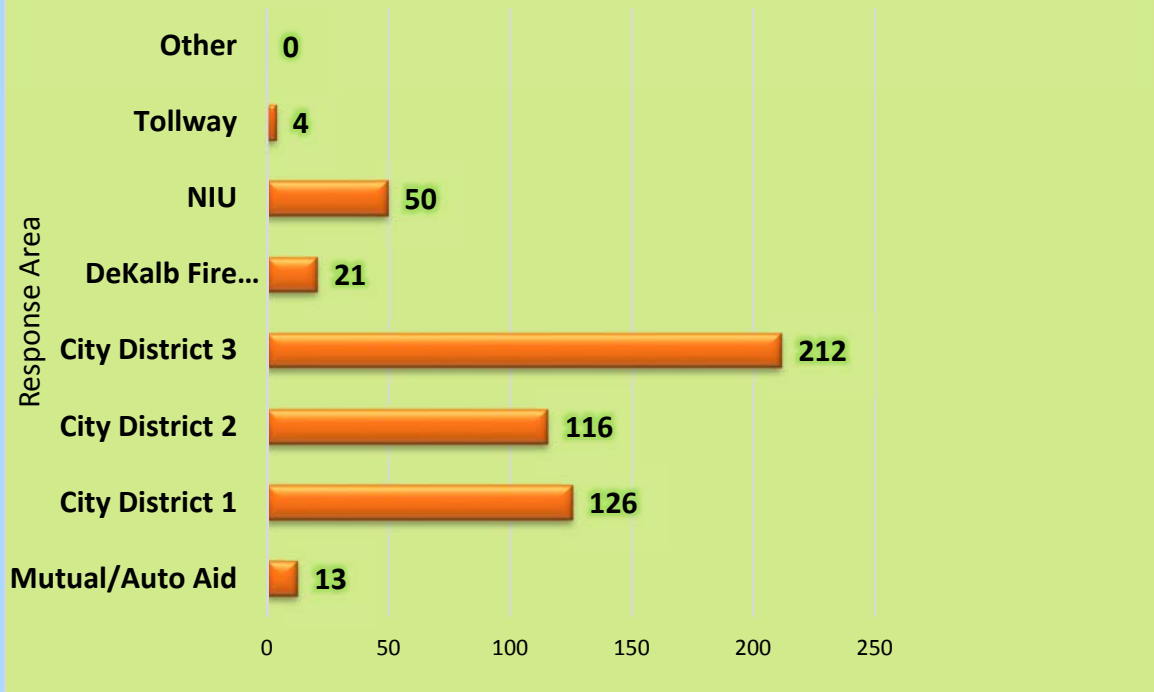


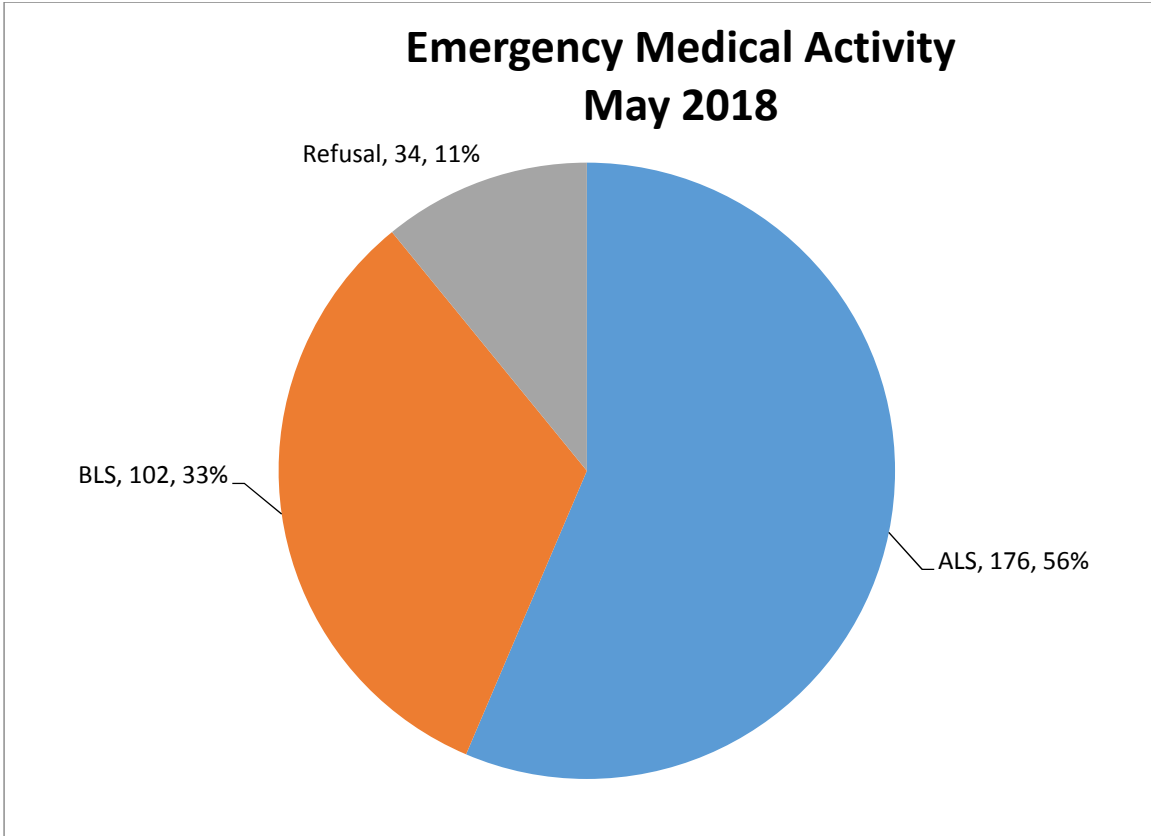
### Calls By Station

542 Total Incidents

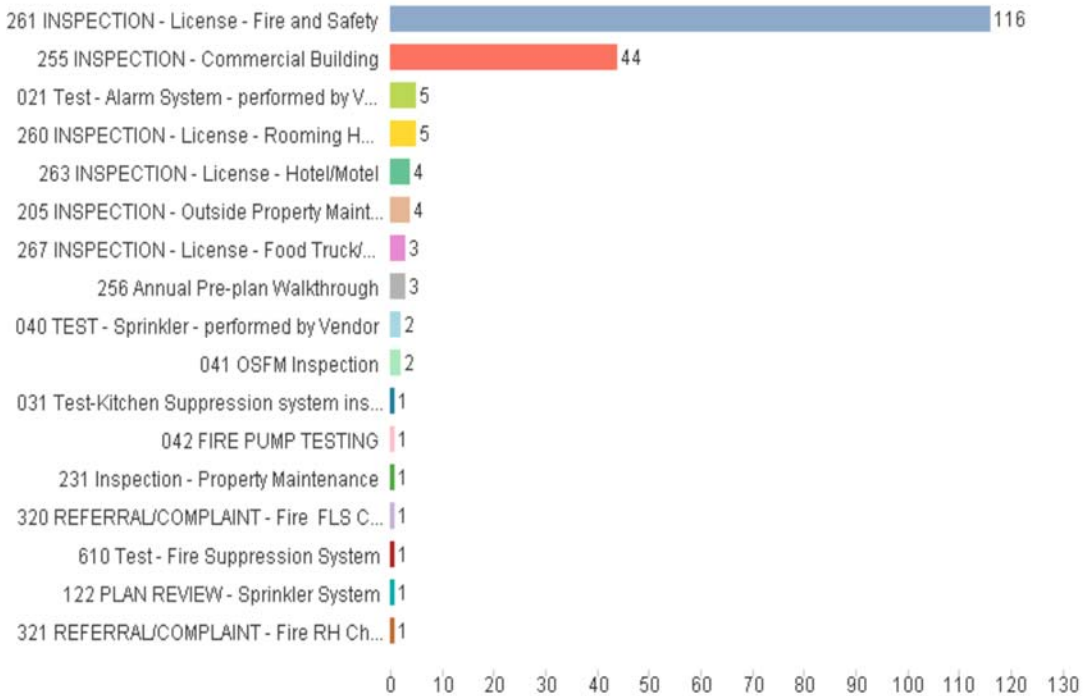


### Calls by Response Area
